World Mission University Scholarships Guidelines

Article I General Provision

Section 1. (Origin) WMU scholarships are given to model missionaries, faithful ministers and talented lay leaders for their further developments.

Section 2. (Purpose) The guideline sets relevant rules for WMU to select and distribute scholarship to fulfill its educational purpose.

Section 3. (Administrative rules) Scholarship preceding is to follow WMU's rules and regulations that are set by the Scholarship Committee and scholarships are distributed after the President's approval.

Article II Selection of Students for Scholarships

Section 4. (Qualifications) In order to be qualified for scholarship candidates, WMU students must meet following qualifications:

- 1. After graduation, he/she must have a sense of calling or vision to be missionaries or pastors.
- 2. Be a model Christian
- 3. Having financial difficulties
- 4. Demonstrate excellent leadership
- 5. Registered as a fulltime student (undergraduate 12 units/ graduate program 9 units)
- 6. Audit students and research students are exempted
- 7. No disciplinary actions received during academic year
- 8. In previous semester, total 12 units for undergraduate/ 9 units for graduate students with GPA 2.5 or higher (no F grade accepted; exception is made for the special scholarship recipients).
- 9. Eligible for receiving scholarships (Except Article 3, Section 8, clause 8 and clause 12).

Section 5. (Selection) Candidates are selected as follow:

- 1. Beginning of each semester, Scholarship committee reviews the applications and selects the recipients based on GPA, Christian conducts and need based.
- 2. With few exceptions, no same students received multiple awards or scholarships.

Section 6. (Application) Students who are interested in receiving awards or scholarship must fill out applications each year. There will be announcement from the Registrar Office at the beginning of the

semester.

Section 7. (Announcement) Normally, Scholarship recipient students will be notified by mail.

Article III Number of Scholarships and Awards

Section 8. (Names of Scholarships) Following scholarships are given by WMU:

1. Alumni Student Scholarship

Alumni Student scholarship is awarded to the students who graduated WMU Bachelor programs and then registered in WMU master programs such as M.Div, MAT, MAM, and MACC. A 30% tuition discount is given to the students. In addition to that, the M.Div program students who graduated WMU Bachelor programs can receive an extra 20% tuition discount from the Founder Scholarship. For all kinds of Alumni Student Scholarship, student must maintain a G.P.A of 2.5 or higher. If the G.P.A falls below 2.5, the scholarship will be rescinded.

2. Oversees Mission Scholarships

This scholarship is awarded to those furlough students who have ministered more than 3 years in different countries and plan to go back to the mission fields. The Scholarship Committee will review each applicant at the beginning of each semester. The recipient will be waived between 25% of tuitions. Unmarried Children(under 30 years old) of missionary will be waived between 25% of tuitions.

3. Family (Student Couple) Scholarship

If family members, (Student Couple) study at WMU, one of them, who have fewer units, will receive a half of tuition as a scholarship. If the GPA is below 2.5/2.0, scholarship is denied.

4. Work-Study Scholarship

- 1) Students, who work various capacities at WMU, are eligible for Work-Study scholarship, and the Scholarship Committee sets number and amount of scholarships. Recommendations are made from each department, and notify the Scholarship Committee.
- 2) Tabulations are based on quality and quantity of Work-Study.
- 3) Work-Study scholarships are distributed each month with approval of manager of the students.

5. Outside Donor Scholarships

Government, church, or organization or individual donations or scholarships are given according to its specific guidelines otherwise, it will be distribute according to the Scholarship Committee.

6. Pastor's Scholarship

Given to Pastors or pastor's wife with 25% of tuition as a scholarship.

Unmarried Children(under 30 years old) of pastor receive 25 % of tuitions.

7. Matching Scholarship

WMU will match any third party scholarship a student earns, dollar for dollar, up to \$ 250 per semester.

8. Staff Family Scholarship

- 1) Staff, unmarried children(under 30 years old) or spouse at WMU receives a half of tuitions as a scholarship.
- 2) Scholarships are awarded to unmarried children(under 30 years old) of retired staff or death of staff up to half of the tuition.
- 3) Scholarship does not include online class, individual/private lesson, and fees.

9. Student Council Scholarship

Member of Student council receive fixed scholarship (i.e. President of council \$1,250; Vice-president, Secretary (\$700).

10. Designated Scholarship

Designated Scholarship is awarded according to churches or individual's specific guidelines and mandates.

- 2) Bong Mo Scholarship (Elder Chung Bong Mo)
- 3) Kyoung Ae Scholarship (Daughter of Rev. Won Hee Lee)
- 4) Sung Hwan Scholarship (Rev. Sung Hwan Yoon)
- 5) Yong Jang Seoung Scholarship (Son of elder Byoung Joo Lee)
- 6) Soon Ja Scholarship (Kwan Sa Soon Ja Jung)
- 7) Kun Joon (Elder Kun Joon Jang)
- 8) Dong Soon Scholarship (Mother of Mrs. Helen Lim)
- 9) Kuem Soon Scholarship (Mother of Mrs. Jong Hyun Lee)
- 10) Dae Soon Scholarship (Mother of Young Ja Lim)

Section 9. (Category) WMU has following categories:

1. University

- 2. Outside donations
- 3. Extra income from Scholarship funds

Section 10. (Distribution) Scholarships are distributed as following guidelines:

- 1. Students cannot be awarded more than one category (except Work-Study, Student Council, and Designated scholarship).
- 2. One student cannot receive full tuition scholarship in a specific semester.

Music student scholarship does not include private lesson fees) except Work-Study and Designated scholarship).

- 3. Any misrepresentation is found, scholarship may be revoked or asked to return them.
- 4. Students with a disciplinary action can result cancellation of scholarships.
- 5. There must be no outstanding tuition balances.

Section 11. (Guidelines for Procedures) Applicants must observe following guidelines:

- 1. Application must be complete each semester.
- 2. There should be two types of personal essays for Requesting scholarships.
- 3. Student who receives more than \$1,000.00 cannot apply.
- 4. Deadline is Thursday of third week of each semester.

Addendum

Section 1. (Addendum) The Scholarship Committee and Academic Affair Committee must approve following addendum.

Section 2. (Notification) Effective date starts on September 3, 1990.
